WEARE BOARD OF SELECTMEN MEETING MINUTES April 4, 2016

7:00 p.m. Vice Chairman Clow called the meeting to order with the Pledge of Allegiance followed by a Moment of Silence.

PUBLIC COMMENT

Resident Richard Butt asked why the \$25,000 trade-in value of the loader was not included in the warrant article or mentioned in the mailer or deliberative session. He noted it was mentioned during the CIP meeting. He felt the taxpayers were overtaxed because the highest bidder was \$145,000 and the warrant asked for \$185,000. He believes the way this is written that the money cangot be used for anything else.

It was discussed that the trade-in value is not always approved before the vote and there were concerns if the loader were to break down at the time of purchase what the trade-in value would be. It was also noted the specs changed after the warrant was approved.

Mr. Butt suggested the word õanticipatedö would allow some õwiggle roomö. Town Administrator Naomi Bolton stated that this year the new DRA Advisor deleted the word õanticipatedö and combined the wording from two sentences into one.

Mr. Butt also asked about the seven TuffBooks computers that were approved in January 2014 and if they were all installed and working. Five were to go police department and two to the fire department. (Chief Kelly will address later)

DEPARTMENT HEAD AND COMMITTEE ITEMS

Garage Door

Police Chief Sean Kelly has three quotes to fix the garage door. He was informed entire mechanics behind the door was designed for residential use and not intended to lift the size of the door and the multiple uses for the duration the building has been there. During the last two weeks, the door dropped twice because the motor stops running and the mechanism does not have the strength and the door comes down. In his opinion, it was destined for failure and has gone past any reasonable safety consideration.

Ron Wescott Door quoted \$2,500; Garage Door Hero quoted \$1,998 and Over Head Door is \$2,995. Selectman stated that some of the vendors will replace the tracks and include remotes while one will not, so the quotes are difficult to compare therefore Chief Kelly will ask for quotes on specific specs.

Chief Kelly addressed the TuffBooks. The history is they were not installed in the cars in 2014 by former Chief Velleca. The installation budget from Spaulding Hill included \$70 for the computer stand but that was inaccurate and the cost is closer to \$700 per stand. With the significantly difference in cost and the 2015-2016 cruiser warrant the installation was put on hold. It was also determined the way the TuffBooks are configured they are not CJIS compliant therefore any exchange of information over radio or internet/microwave would be a violation of communication laws. This piece has been corrected.

Another obstacle was the move to Goffstown dispatch required the installation of additional hardware that was beyond what was not anticipated with moving communications from Bow to Goffstown which is part of 2018 budget. New Boston also moved to Goffstown and is installing the equipment at their expense.

Chief Kelly reported since July 2014 he has never seen five TuffBooks in the police department, only four.
