# CIP SUBCOMMITTEE MINUTES OCTOBER 17, 2012

#### I. CALL TO ORDER:

Jack Dearborn opened the meeting at 8:00 AM in the conference room of the Weare Town Office Building.

#### II. MEETING:

Parks & Recreation: Melissa Drury was present representing the Parks and Recreation Commission. She handed everyone a new request for Ball Field Development for a total cost of \$285,000 with a request of \$135,000 for 2013 and \$75,000 for 2014 and 2015. The proposal would be to develop four new fields. The subcommittee then discussed the current inventory of fields, not just the Town ones, but the ones located at each of the schools. The discussion continued about the ability of possibly coordinating and working with the schools for field use. The concern was if this proposal was based on the expansion of the Ineson Field off of Quaker Street or the possible East Street location. The East Street property is in the midst of getting acquired but it is going to take a vote of the Town for approximately \$200,000 to allow for the purchase. Questions were also asked regarding moving forward with the completion of Bolton Field. A study was conducted several years ago that showed the total build out showing an indoor facility and some walking tracks. There has been no discussion currently about working toward the completion per the plan.

Richard Butt moved, Stu Richmond seconded the motion to approve the Parks and Recreation request for additional ball fields with a cost of \$135,000, with a ranking of 6 – premature. Vote: 0 in favor and 5 opposed, therefore the motion fails and the request will be noted as such.

#### III. NEXT MEETINGS:

The next subcommittee meeting will be Wednesday, Oct. 24<sup>th</sup> at 8 AM.
