- Gate at football field at Bolton will need repair/replacing
- With WAC constructing new storage shed/snack shack, would like to consider converting existing snack shack into PARC storage. Door on snack shack will need to be replaced.
- Would like to consider resurfacing the field at the Gazebo. Back field is currently dirt and rocks. No grass. Possibly create a berm for ice rink purposes.

Consider fencing or some other sort of barrier around Ineson field.

Tennis Court

1. Discussion on alternatives for tennis courts. One side is in greater disrepair than the other. The front court has greater cracks and heaves as opposed to the back court. Possibly convert the front court to a pickle ball court which requires a smaller court space. Or convert to a volley ball court where a barrier could be installed and sand placed or demo the front court down to the ground and have sand placed. Leave the back court for tennis.
