I. CALL TO ORDER:

The meeting was called to order by Chairman Clow at 7:08 PM.

II. MANIFESTS:

Chairman Clow moved to authorize the Board of Selectmen to sign manifests and order the Treasurer to sign checks dated February 3, 2011 in the following amounts:
