## **PUBLIC COMMENT**

Frank Campana wanted to discuss the police car that was in the accident. He has gone and looked at it three times. He has received a copy of the written appraisal that was done for the insurance company. In looking at the car, he felt it appeared to be cosmetic only, a crunched fender that didnøt look too bad and a broken tail light. In looking at the appraisal it calls for a replacement bumper for \$500 plus labor and materials, plus the tail light repairs for a total of approximately \$2,300. Mr. Campana was questioning if it was worth making a claim. He asked that the Board and the Chief go look at the car before fixing it. He feels it is simple to fix but doesnøt feel it is worth fixing it as the appraisal indicates.

Chairman Lacasse swore Jan Snyder in as the Deputy Treasurer.
