



## What To Do If You Suspect a Possible Conservation Violation

In the event that you are concerned that a possible conservation violation has occurred on a Weare conservation parcel, there are several available options:

1. Contact the land owner and express your concern in a non-confrontational manner. The landowner may not realize there may be a problem and a friendly conversation can avoid or resolve a misunderstanding.
2. Contact the appropriate enforcement authority. The responsible authority will depend on the type of suspected violation. In some cases, it may be the town code enforcement officer, while in other cases state agencies such as the NH Dept. of Environmental Services (NHDES) or NH Fish and Game Dept. 3. Contact the Weare Conservation Commission at [conservation@weare.nh.gov](mailto:conservation@weare.nh.gov). The Commission welcomes questions regarding conflict resolution of conservation issues and/or the steps involved in filing a complaint with the State. Providing information about best management practices can avoid problems that might result in an administrative order from the State to cease and desist, possible fines, or other legal action. Please keep in mind that the Weare Conservation Commission does not have legal enforcement authority but can offer possible course(s) of action and, hopefully, resolution. The Commission's intent is to resolve issues before they rise to the level of a violation requiring enforcement or legal intervention.
