Procedural discussion

Motion to Recommend Article 09: Article read by Megan Thellen. James Drury motions to recommend. Tom Clow issued a second to recommend Article 09.

Discussion:

Bill Anderson – Current vs. proposed 4.46% increase current v default 2.35% increase. If the FC follows a line to maintain it would be about a \$322 increase on a \$250,000 home. If CARES funds are received, the default budget will be the best option.

Neal Kurk – Since there was additional funds from last year there should be enough surplus to cover the additional budget costs. Naomi deferred to Beth but she cannot be heard. Naomi explained that the money was not spent and warrant article that were not fully expended. The 2020 surplus was in the range of \$293,000, add warrant article leftover funds \$307,000. Tax offset was about \$350,000

Tom Clow – the prior year used for tax rate because the year has not been audited. The actual amount will not be known until an audit. Question regarding the default – police budget – full time salary proposed higher than default due to hiring of more senior officers. The figures should be the same in both proposed and default. Believes it should be discussed by selectman prior to session or get a legal opinion.

Neal Kurk – number from last year should be the same in the proposed budget due to the state law.

Naomi – increase two officers and a promotion. All in proposed not in default.

Neal Kurk – what is the salary increase per person?

Naomi – Increase 2 officers – both 3% Avril \$1810, Lewis 3%, Muese promoted to Corporal \$14,000

Chris Hague – the budget does seem to include any items that are unnecessary. More safety items.

Megan Thellen – re: Neal questions regarding increases – dept heads gets budget increase do they all get the non-union increase as well?

Naomi – yes because the increases are already in effect.

Tom D. – comment – there was a 40% increase for the Library director was off putting but that was not why the budget was voted down. Do we agree with the process and if not, the selectman are elected and can be replaced. Do the Selectmen have the ability to change set funds?

Chris H. – the FC should see all the budgets before we get the warrant. Cannot change anything set with trust funds.

Nicole – agrees with Bill but has an issue with taking into account where we are with WSD maybe not going to be as willing to approve other town items.

Neal – the FC can go back and review if the final impact is larger than we feel comfortable with when we all completed with deliberations.

Tom C. feels it is a reasonable budget

Nicole – Tax impact of all yes?

Megan - yes vote would equal \$5.60 last year was \$4.79

Bill A supports adding another vehicle. Need to be able to support the staff. Chief would like to trade in cars to get SUV which are more practical

Neal – why is there a line item that has zero for police vehicles?

Naomi – considered adding one to operating and the other to a warrant article. The line item was removed to ensure transparency.

Chris – Can the verbiage be changed from fully equipped to equipped?

Tom D. – We should vote on it as is and allow Bill to add detail to the recommendation statement

Tom C clarified that they are down 3 cars
