## WEARE FINANCE COMMITTEE JANUARY 24, 2019

- The Weare Finance Committee met on Thursday 24 January at 7pm at the Town Offices. All Committee members were present except Gregg McDowell. Also present were Town Administrator Bolton, Finance Administrator Rouse, Board of Selectman Chair Hippler, additional members of the Select Board, Weare School Board Chair Burke, Fire Chief Vezina, and Public Works Department Head Knapp.
- 2. Business. Administrator Bolton briefed the Committee and provided information on reductions in the Town proposed budget totaling \$80K. The revised proposed budget of \$6,116,300 now represents a 1.4% increase over the 2018 approved budget.
