# -- APPROVED MINUTES --

Minutes Board of Trustees Meeting Friday, June 7, 2013

**Present:** Trustees Chairman Raymond Kelly, Trustees Susan Morin and Paul Marsh The meeting was called to order at 6:11 pm as per RSA 91-A:1-a.

## Acceptance of Minutes:

The meeting minutes from April 4 and May 3, 2013 were reviewed. The April minutes were corrected to note that only the March 7<sup>th</sup> Minutes were postponed, the February Minutes have already been accepted. The attachment to the May 3<sup>rd</sup> Minutes, describing the date of the Hearing to Accept Funds, was amended to from May 2 to May 3. No other changes were noted; both the Minutes of April 4th and May 3rd were approved. All present were in favor.

## Public Session to accept funds:

A public hearing came to order at 6:20 pm, per RSA 202-A 4 c. The hearing was held to accept \$562.89 in funds from income generating equipment, a grant, donations and other income (see attached table), to be placed in the appropriate funds. All present voted in favor of accepting the report. The public hearing ended at 6:40 pm. A copy of the report is attached.

# **Non-Public Hearing:**

The Trustees entered a Non-Public Session at 6:41 pm, per RSA 91-A-2, for the purpose of reviewing and discussing personnel matters. The session ended at 7:58 pm.

The Trustees discussed salary allocations for staff, based on the voter approved town warrant for that purpose.

# **Director's Report:**

The Director's Report for the month of May was reviewed. Director Hague was hosting a public event at the Weare Town Hall, and was not able to expand on the report. All present were in favor of accepting the report.

## **Old Business:**

The Library's updated Technology Plan was presented and discussed. A few minor changes were suggested by Trustees, and will be discussed further with Director Hague.

A communication from Vachon and Clukay, auditors for the Town of Weare, was received, and made some suggestions regarding a tightening of the Library's fiscal procedures. All present agreed that these procedures should adopt the firm's suggestions, and Trustee Morin and Director Hague will determine the best way to do so.

The Trustees ended Non-Public Session at 9:15 pm. No final decisions were reached, and no votes were taken within the Session.

No further business appearing, Trustee Marsh moved, and Trustee Morin seconded, to adjourn the Trustees Meeting. All voted in favor. Meeting adjourned at 8:03 pm.
