PUBLIC COMMENT:

Todd Fischer - Representing Weare Athletic Club

WAC proposes construction of a 24' x 20' storage/concession/announcement shed at Ineson Memorial Field. This shed would be used for WAC equipment storage and concession purposes. To be wood construction, asphalt shingle roof, vinyl siding, steel doors. The two current dilapidated shed structures will be demolished upon completion of the new structure. Volunteers will complete the construction work. To be constructed in front of the two existing sheds.

Randy Magoon - motion to move forward with project and present to the Board of Selectmen at next meeting provided PARC is provided with a scope of work and materials and confirmation with Chip Meany regarding code requirements. Karyn will attend the BOS meeting in support.

<u>Sherry Burdick – Representing Weare Historical Society</u>

Sherry Burdick commented on number of events in town by local organizations. They seem to be close in date, which may have an impact on the attendance level. Proposed making the PARC field day part of the Historical Society's Old Home Day event. Randy Magoon noted that while PARC wishes to and is happy to participate in other organizations' events by way of funding a portion of the event or participating at the event, PARC would like to keep PARC-sponsored events separate. PARC had scheduling obstacles this past summer which landed the Family Field Day later in the season that originally anticipated and we competed with soccer schedules. The scheduling of events between the Sugar & Spice Touch-a-Truck, the Patriotic Celebration, the Historical Society's Old Home Day event and the Family Field Day made them only weeks apart. PARC plans to solidify dates farther in advance and make the dates known to other organizations in an attempt to avoid this same problem going forward.

Mike Sullivan inquired about having one central location for posting community events. The library is willing to undertake the task of maintaining a town-wide activity information calendar. He will look into creating same.
