Memorandum of Understanding (MOU) received from School Board. Karyn and Randy to attended the School Board Meeting on 4/18/17 to review the MOU with board and iron out final details. Tom Clow from Board of Selectmen also attended. PARC requested no age limit be placed on use of the area. PARC will coordinate signage once the school board approves the wording. The school board will cover the cost of the signage. PARC will have fence repaired and the main gate locked up. School to maintain garbage while school in session. PARC to maintain garbage otherwise.
