1. Field Usage:

7. Chase Park:

Park is now closed for the season. The septic tank was emptied by Towne's at \$315 for the 1500 gallon tank. Bathrooms have been winterized. Will need to inquire about sand for the beach. Do in the spring before opening.

New swim lines:

Can order pre-assembled lines or separate rope and floats to put together ourselves. After researching prices, the most inexpensive of each option: two lengths of preassembled 600 ft. lines with 5x9 floats total: \$2,762.50 (poolweb.com) **or** to-be-assembled (2) 600 ft. rope spools and 240 floats total: \$2,216.64 (wmsaquatics.com). After discussion will go with to-be-assembled option and perhaps make it into a community service project for JSRHS students.

There was a budget freeze imposed at the end of October. In speaking with the Town Administrator, it was determined that we may be able to move forward with the purchase of the new lines in mid-December. Karyn will be in touch with the Town Administrator on moving forward with the purchase as mid-December draws closer.

8. Seniors:

Possible dinner with Nana's to cater. Considered doing in December, but will hold off until perhaps February just before town meeting or voting. Nana's suggested quiche, salad and dessert at \$9.50/person plus tax. Would anticipate maybe 40 attendees totaling approximately \$414.20.
