Sign Permit Sauvagean, 954 River Road

The Board reviewed a sign application for a 2'x3' sign, 7' off the ground. The non-lit sign is for 'Cast and Blast Guide Services'.

Neal Kurk moved to approve the application of Nicole Sauvagean of 954 River Road for a sign as presented in the application, dated April 15, 2013, provided that the height of the sign not exceed 6' as permitted in town ordinance Article 34.10.1.2. George Malette seconded the motion. Discussion: George Malette asked if they are approving a sign for a business, shouldn't they know what the business is? Chip Meany said he has to assume it meets guidelines and they don't need his approval. Mr. Meany would only act if someone made a formal complaint about the business. All voted in favor.
