- BOS no mention
- CC mentioned purchase of conservation easement on a farm for agricultural preservation
- PARC noted athletic field shortages and overuse

1/9/2013 CC Meeting noted that BOS developing Banks/Shmid warrant article

1/21/2013 BOS Meeting re. warrant

 Article 30 (subsequently revised to Article 29) includes designation of 20 acres for gravel pit and recreation fields

2/2/2013 Deliberative Session (first part Town Meeting) comments re. Article 29

Conservation easement will allow agriculture or forestry with passive recreation

2/13/2013 CC Meeting member report re. deliberative session

- "The land includes 117 acres of scenic agricultural fields and forest, all of which will be placed in conservation easement and remain undeveloped."

3/12/2013 Second part Town Meeting – Annual Town Election

 Article 29 with conservation easement requirement and gravel/recreational fields exclusion passed 774 to 547 votes

3/25/2013 BOS Meeting re. Banks/Shmid

Discussion regarding agricultural use and haying approval

8/14/2013 CC Meeting re. project funding concern

- Town Administrator, BOS, and seller very concerned about project funding and timing
- CC committed additional \$130,000 to purchase from the town's Conservation Fund
- Property exclusive of gravel pit/recreation field is to be managed by Conservation Commission as conservation land

9/11/2013 CC Meeting re. project status

- Clarity that CC intends agricultural lands (hayfield) to be preserved
- Purchase lead transitioned from Russell Foundation to SPNHF

12/2/2013 CC Meeting with concurrent BOS Meeting

 "Chairman Clow confirmed the understanding that the existing hayfields are to remain in agricultural use."

12/2/2013 BOS Meeting re. discussion of East Road property

- Chairman Clow stated "Ball fields may be challenging to develop on that lot."
- Steve Najjar commented that CC funding stipulated that parcel to be conservation land managed by the CC

- BOS "farmland" and forest will be put into conservation
- CC field and forest value mentioned as well as eventual recreation field development in the reclaimed gravel pit

- Important to CC that purchased "acting through the Conservation Commission" as first draft of deed language originally indicated
- Mention that 20 acres needs to subdivided out
- "Interior" exclusion has to show up on maps

4/8/2014 Closing on the parcel purchase

4/9/2014 CC Meeting with Cooperative Extension specialist

- Invited by member Stevens (also of Agriculture Commission)
- Addressed hayfield condition and management

4/21/14 BOS Meeting re. closing papers

• Noted that purchase was a "bargain sale" at \$540,000 which indicates the sale price was below full value (\$60,000 less than the price in the Purchase and Sale). According to the seller, the reason it was below full value was to assure the preservation of the hayfield.

7/9/2014 CC Meeting re. hayfield

8/13/2014 CC Meeting re. project status

- Waiting for conservation easement
- Hayfield being mowed

12/31/2014 Town Annual Report re. Banks/Shmid

- BOS preserving rural environment with acquisitions and easements such as along East Road and will continue to see East Road in the future much as it is today
- CC parcel purchase is completed, under CC management except gravel pit and athletic fields
- PARC no mention

4/8/2015 CC Meeting re. conservation easement

- Brian Hotz of SPNHF speaking on easement status
- "Donut hole" mentioned, indicating easement exclusion area (gravel pit and recreational fields) doesn't include the hayfield but is to be located somewhere towards the middle of the property

6/10/2015 CC Meeting with Brian Hotz in attendance again

- Awaiting feedback from town re. surveying and easement language
- Discussion of hayfield management options

9/9/2015 CC Meeting re. further expenditure from town's Conservation Fund

- CC agreed to repay Russell Foundation's bridge loan from Conservation Fund
