Collectively consider:

1. Type of road servicing junkyard.
2. Road(s) the junkyard may be seen from.

3. Natural or artificial barriers blocking view of the junkyard.
4. Proximity to established tourist and recreational areas or main access routes to them.
5. Reasonable availability of other suitable sites for the junkyard.
7. RSA 236:116 Hearing . Not less than 2 nor more than 4 weeks from date of the receipt of the application by the governing body. Notice of the hearing shall be given to the applicant by mail, postage prepaid, to the address given in the application and the notice shall be published once in a newspaper having a circulation within the municipality, which publication shall be not less than 7 days before the date of the hearing
8. RSA 236:121 After hearing, Selectmen shall make a finding within 2 weeks as to whether the application should be granted or not.

If granted, it shall remain in effect until the following June 30th.

Approval cannot be transferred to another party.

Licenses shall be renewed thereafter upon payment of the annual license fee without hearing, if all stated conditions are complied with, and the applicant is not convicted of any type of larceny or of receiving stolen goods.

9. RSA 236:122 License Fees . Annual license fee is \$25.00 at the time of application, and annually thereafter in the event of renewal. Fee returned if application is not granted.
10. RSA 236:123 Fencing . Before use, a new junkyard shall be completely enclosed with a solidly constructed fence at least 6 feet in height which substantially screens the area and with a suitable gate which shall be closed and locked except during the working hours of the junk yard or when the applicant or his agent is within. Where topography, natural growth of timber, a natural barrier or other consideration accomplish the purposes and intent and needs of this paragraph, the Selectmen may reduce the fencing requirements to the degree they feel is required.
