
Meritorious Service Award

On March 15, 2013, Sergeant Kelley received a call from Headquarters regarding a call from another town concerning a past tense sexual assault which had allegedly occurred in our town. As a result of the information received Detective Hebert was contacted and informed of the assault. As the department sexual assault investigator, Detective Hebert interviewed the victim and determined there was probable cause to believe a sexual assault had occurred. The victim had identified the two suspects and information was gathered concerning the whereabouts of the two. Warrants were obtained for the individuals and the residence.

With the assistance of Officer Nadeau, Officer Montplaisir, Officer McSweeney and Sergeant Kelley, Detective Hebert proceeded to the alleged residence of one of the suspects in our town, evidence was gathered and one of the suspects into custody. They learned the other suspect was in another town and made arrangements for that department to take him into custody. Within 24 hours after receiving the first call, Detective Hebert and his fellow officers had both suspects in custody and in Valley Street Jail.

Detective Frank Hebert is hereby awarded the Meritorious Service Award for his diligence in this investigation and subsequent arrests.

LETTER OF COMMENDATION

It is with great honor that I write this letter; on 03-15-2013 we received a report of an alleged sexual assault that occurred within the jurisdictional limits of the Town of Weare. This resulted in a subsequent investigation, the subject of which produced two arrests 13-44-AR and 13-45-AR.

During the investigation process it was determined one suspect was currently on parole for a serious armed assault involving a firearm. Together the officers of our agency put their best foot forward in one of the most impressive show of teamwork and dedication I have seen in a long time. Some members required being up for more then twenty hours with out any complaints or lack of performance whatsoever. As a supervisor, I am proud to work along side such dedicated officers.

The investigation process and subsequent arrests, combined with the seriousness of the offence at hand required extended travel to the Town of Dover, NH which further placed a strain on resources of our already understaffed department.

The members involved in this process never showed any weakness; in fact I received complements from Dover Police Sergeant William Malsbury as to your skill level and professionalism during communication with their agency and while on the ground in Dover. This combined with the fact we were able to complete an investigation, prepare the warrants, make the arrests and subsequent search of the crime scene all in one day and with out any issues is exceptional to say the least and well represented of your agency and the community you serve.


