Arrests

Possession of Drugs: April 1– A motor vehicle stop occurred in the area of South Stark Highway and Duck Pond Road for speed (66mph/50mph zone). During the motor vehicle stop an investigation ensued where officers recovered psilocybin mushrooms. The male operator was placed under arrest and later released on PR bail. This felony level case has been sent to the Hillsborough County (North) Attorney's Office.

Domestic Violence Simple Assault: April 3 - Weare Police responded to a residence after receiving a report of domestic violence. After an investigation, an adult female was arrested for Domestic Violence Simple Assault. She was later released on personal recognizance bail.

Juvenile Petition Served: April 6 - Weare Police served a juvenile petition for an OHRV incident which occurred on March 18.

Domestic Violence Simple Assault: April 7 - After receiving a E-911 call, Weare Police responded to a residence for domestic violence. After an investigation, an adult male was arrested for Domestic Violence Simple Assault and Obstructing the Report of a Crime. He was later released on personal recognizance bail.

Arrest on Warrant (Hollis PD): April 9 – Weare Police were contacted by the Hollis, NH Police Department requesting service of a felony arrest warrant for the crimes of Identity Fraud, Credit Card

Fraud, and Theft by Deception. Weare Officers responded to the suspect's residence where he was taken into custody without incident. He was transported and later turned over to the Hollis Police Department.

Driving While Impaired: April 13 – After conducting a motor vehicle stop in the area of River Road and Chuck Street for speed (44mph/30mph zone) officer's initiated an investigation for driving while impaired. The operator was subsequently arrested for Driving While Impaired (drugs). He was later released on personal recognizance bail.

Driving While Intoxicated: April 14 - Weare Police conducted a motor vehicle stop for multiple traffic infractions to include following too close, and failure to dim. Officer's made contact with the female operator who exhibited signs of impairment. A roadside investigation ensued and she was subsequently arrested for Driving While Intoxicated. She was later released on personal recognizance bail.

Arrest on Warrant (Obstructing Government Administration): April 21 – An adult male turned himself into authorities on multiple warrants. We are Police had an active arrest warrant from an incident which occurred on December 24, 2021. During police contact, the individual provided a false name to law enforcement. This was later discovered when the involved officer furthered the investigation of the motor vehicle stop. He was provided a court date at Goffstown District Court in April.

Arrest on Bench Warrant: April 22- An adult male was arrested on a bench warrant after Weare Police conducted an administrative search of his license plate revealing an active arrest warrant. The male operator was later released on cash bail.

Arrest on Bench Warrant: April 24- An adult male was arrested on a bench warrant. Weare Police were conducting a business check at a local business when an administrative search was conducted on a vehicle parked in the parking lot. It was discovered the owner had an electronic bench warrant for violation of court order. He was placed under arrest and later released on PR bail.

Driving While Impaired/Reckless Conduct: April 27 – Weare Police received a complaint of an individual who appeared to be impaired and

recklessly handling a firearm. The individual was located at the Weare Mobil Station. An investigation occurred and he was subsequently placed under arrest for Driving While Impaired drugs (2nd offense), Reckless Conduct, and Interlock MV not equipped. He was later released on personal recognizance bail. This felony level case has been sent to the Hillsborough County (North) Attorney's Office.

Arrest on Warrant (Possession of a Controlled Drug): April 27- An adult female turned herself into the Weare Police Department for an active felony drug warrant. The warrant stems from a motor vehicle stop on November 13, 2021 in which psilocybin mushrooms were recovered. After receiving analysis results back from the forensic lab and arrest warrant was issued. She was later released on personal recognizance bail. This felony level case has been sent to the Hillsborough County (North) Attorney's Office.



Work Zone Safety

The Weare Police Department wants to prepare you with safety tips for entering work zone areas to avoid making deadly mistakes while driving.

A work zone is an area of roadway where construction, maintenance, or utility-work is being performed. A work zone is typically marked by signs, channeling devices, barriers, pavement markings, and/or work vehicles.

When entering a work-zone, you should minimize distractions at all times and dedicate your full attention to the roadway.



PROCEED WITH CAUTION!

You should always expect the unexpected when entering a work zone. When driving through a work zone, workers, work vehicles, or equipment may enter your lane without warning. Other vehicles driving through the work zone may suddenly slow down, stop, or merge into your lane while maneuvering the obstacles of a work zone. The best way to ensure everyone's safety is to focus on the road and to prepare for unexpected occurrences.


When in a work zone, obey the posted speed limit. However, normal speeds

may be reduced. The reduction of speed limits has a purpose, and it's to ensure the worker's and the driver's safety!

Enhanced Penalties

All states have some form of enhanced penalty for committing traffic violations in a work zone.

In the United States, 24 states & D.C. require workers to be present in the construction zone for the enhanced penalties to take effect.
