## **Arrests**

Arrest on Warrant (Theft): December 5, 2021 A man was arrested on a Weare Police warrant for Theft by Unauthorized Taking. The arrest stems from an incident in September of 2021 when the suspect completed a bank withdrawal without the owner's permission.

Arrest on Warrant: December 8, 2021 A man was arrested in Massachusetts on two active Weare Police arrest warrants. Our charges stem from incidents occurring on October 3<sup>rd</sup> and November 18<sup>th</sup> of last year. He was charged with six counts of Violation of a Protective Order and Stalking. He was also charged with Conduct after an Accident, Violation of a Protective Order, Domestic Violence Simple Assault, Driving after Revocation, and Operating after being Certified as a Habitual Offender. The Hillsborough County Sheriff's Office provided assistance. The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

**Driving after Rev/Suspension: December 9, 2021**After conducting a motor vehicle stop on Center Road for a speeding violation, we found the operator's driving privileges and registrations were suspended. He was issued a hand summons on scene in lieu of physical arrest.

**Driving While Intoxicated: December 10, 2021** We were dispatched to a single motor vehicle crash in the area of North Stark Highway and Concord Stage

Road and determined the driver was impaired. He was therefore arrested for Driving while Intoxicated.

#### **Driving While Intoxicated: December 20, 2021**

We responded to a single motor vehicle crash in front of the Weare Middle School. Significant damage resulted and the female operator was placed under arrest for Driving While Intoxicated.

**Driving While Intoxicated: December 23, 2021** We responded to a single motor vehicle crash on Mountain Road. While on scene, officers determined the male operator was intoxicated. He was placed under arrest for Driving While Intoxicated.

Driving after Rev/Suspension: December 24, 2021
After conducting a motor vehicle stop for speed on
South Stark Highway near Colby Road we learned
the operator's driving privileges had been suspended.
She was subsequently issued a hand summons on
scene in lieu of physical arrest.

## **Domestic Violence**

Intimate partner violence accounts for 15% of all violent crimes. On average, 20 people per minute are physically abused by an intimate partner in the United States. The Weare Police Department wants to help you escape any abuse you may be experiencing. It's important to be aware of the signs of domestic abuse and what is defined as domestic abuse.

# The law is on your side!

New Hampshire state law defines Domestic Violence, or abuse, as the "commission or attempted commission of one or more of the following acts by a family or household member or current/former sexual or intimate partner (romantic relationship) and where such conduct constitutes a credible threat to the plaintiff's safety:

a. Assault or reckless conduct (RSA 631:1,2,2-a);
b. Criminal threatening (RSA 635:2)
c. Sexual assault (RSA 631:1,2,2-a,4 RSA 632-A)
d. Interference with freedom (Includes stalking) (RSA 633:3)
e. Unauthorized entry (Enter your residence or home against your will, if you are living separately (RSA 635:2)

f. Harassment (RSA 644:4)


# What are some signs of Domestic Violence?

The signs of domestic violence are not always as obvious as they may seem. This is because domestic abuse is as much controlling someone's mind and emotions as it is



Think of the following scenarios. The more scenarios you are saying "yes" to the more "red flags" should be going off in your mind when thinking about domestic abuse and your partner controlling you.

- Does your partner ever put you down, call you names, or constantly criticize you?
- Does your partner threaten to hurt you, the children, or another family member?
- Do you try to keep the kids quiet to please your partner?
- Does your partner say it is your fault that he/she hit you, threw you down, or kicked or choked you?
- Can you call on the telephone or visit friends and relatives without getting permission from your partner?
- Is your partner jealous or possessive of you?

#### WHAT ADDITIONAL STEPS CAN I TAKE TO PROTECT MYSELF?

Your safety is the number one priority. You can obtain Temporary Order of Protection from your Local District or Superior Court. The closest court to Weare, NH is Goffstown District Court.

If the court is closed, you may request the police to obtain a telephonic Emergency Order of Protection. This order is designed to enhance protection against your abuser until the court opens.

Never hesitate to call The Weare Police Department if you believe you may be a victim of domestic abuse. The Weare Police Department wants to know you are safe and ensure you don't have to "walk on egg shells" in your own home!
