### Arrests

**Arrest on Warrant: July 4, 2021** An adult male was arrested in Bedford on an active Weare Police Department arrest warrant from an incident that occurred that morning. It is alleged the suspect stole four catalytic converters from a business in Weare. The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

**Reckless Operation: July 9, 2021** An adult male was issued a hand summons in lieu of physical arrest after conducting "burn outs" on River Road. The operator was charged with Reckless Operation and Operating Without a Valid License.

**Arrest on Warrant: July 10, 2021** An adult male was arrested on an active Weare Police Department arrest warrant. The warrant stems from Weare Police Officers responding to a domestic assault. The suspect denied access to Weare Police Officers preventing a timely response. He was charged with Obstructing Government Operations.

**Driving While Intoxicated: July 12, 2021** An adult male was arrested at his residence after returning home while a Weare Police officer was at the house to speak with him on another matter. The officer made contact with the operator who displayed signs of impairment and was subsequently arrested for Driving While Intoxicated.

**Arrest on Warrant: July 13, 2021** An adult male was arrested at the Weare Police Department for an active felony arrest warrant. The warrant stems from a domestic assault which occurred on June 9, 2021. The case has been sent the Hillsborough County (North) Attorney's Office for prosecution.

**Driving While Intoxicated: July 14, 2021** An adult female was arrested after a concerned citizen called in a motor vehicle complaint. Weare Police Officers were able to make contact with the vehicle and determined the operator was unfit to be driving a vehicle. She was arrest for Driving While Intoxicated (2<sup>nd</sup> Offense).

### **Suspension of Vehicle Registration: July 19, 2021**

A traffic stop on South Stark Highway resulted in an adult female being charged with Operating a Vehicle with Suspended Registrations and Driving after Revocation/Suspension.

### **Assault on Police Officer/ Resisting Arrest: July 20, 2021**

An adult male was arrested after a Weare Police Officer was assaulted by the home owner while conducting a DCYF safety check. He was ultimately charged with Assault and Resisting Arrest.

### **Obstructing Government Operations / Resisting Arrest: July 25, 2021**

An adult female who was the passenger in a motor vehicle was arrested after Weare Police conducted a motor vehicle stop for an unregistered motor vehicle and non-inspection which resulted in the vehicle being towed. The female passenger prevented the Police Officer from conducting a tow inventory and was advised she was being placed under arrest. She did not cooperate with the arrest and resisted. She was subsequently charged with Obstructing Government Operations and Resisting Arrest.

### **Domestic Violence (Simple Assault): July 27, 2021**

An adult male was arrested after Weare Police Officers were dispatched to a location for a report of an assault. Based on the investigation an adult male was placed into custody and charged with Domestic Violence (Simple Assault).

**Driving While Intoxicated: July 28, 2021** An adult male was arrested after Weare Police responded to a car off the road. Officers made contact with the operator of a vehicle who displayed signs of impairment. He was ultimately arrested for Driving While Intoxicated and Possession of False Government Identification.

**Breach of Bail Conditions: July 31, 2021** An adult male was arrested after a home owner contacted the Weare Police Department concerning an unwanted person at their residence. The male was currently out on bail conditions from a previous criminal case which prevented him from being at the residence. He was

located within the residence and placed under arrest for Breath of Bail Conditions.

**Driving While Intoxicated: July 31, 2021** An adult female was arrested after Weare Police responded to a car off the road into wetlands. Officers made contact with the operator of a vehicle who displayed signs of impairment. She was ultimately arrested for Driving While Intoxicated.

### School Bus and School Zone Safety

The Weare Police Department wants to ensure the safety of your children by reminding you how to safely operate your motor vehicle when approaching a school bus or when driving within a school zone.



#### When entering a School Zone

**SLOW DOWN!!!** It is that simple; unfortunately, people do not follow speed limits within school zones. Drive as if there are always children present during school hours.

Please remember to always slow down, look for traffic signals/signs, reduce your speed, avoid passing other vehicles, and lastly never drop your kids off in the street.

#### Dropping off in a School Zone

**Do not-** double park, it blocks visibility for children and vehicles.

**Do not-** load or unload children across the street from the school.

**Do-** Ensure your kids make it safely onto the sidewalk and are supervised.

### Sharing the Road with School Buses

When you are driving behind a school bus, please leave a safe following distance between yourself and the school bus. This allows you more time to stop once the yellow lights start flashing. The greatest danger presented while riding a school bus is when the students are approaching or leaving one.

**Yellow flashing lights:** indicates the bus is preparing to stop to load or unload children. Motorists should slow down and prepare to stop their vehicles.

**Red flashing lights and extended stop arms:** indicates the bus has stopped and children are getting on or off. Motorists must stop their cars and wait until the red lights stop flashing, the extended stop-arm is withdrawn, and the bus begins moving before they can start driving again.



### **Reminder:**

According to NH RSA 265:60, In a posted school zone, you must drive at a speed of 10 miles per hour below the usual posted limit from 45 minutes prior to each school opening until each school opening and from each school closing until 45 minutes after each school closing.

\*Be alert, children are often unpredictable and they tend to ignore hazards and take risks. Expect the unexpected around a school bus, and be on alert for children!\*
