Arrests

Arrest on Warrant: August 4, 2021 An adult male was arrested in Peterborough, NH on an active Weare Police Department arrest warrant from an incident that occurred on July 2, 2021. The suspect was charged with Violation of a Protective Order, Stalking, and Breach of Bail.

Domestic Violence: August 8, 2021 An adult female was arrested at her residence after Weare Police Officers were dispatched to the residence for a reported domestic dispute. After a brief investigation

she was charged with Simple Assault and Domestic Violence.

Arrest on Warrant: August 11, 2021 With the assistance of the Hillsborough County Sheriff's Office and Concord Police Department, an adult male was arrested on a warrant at his residence in Concord in connection to the burglary at TMS Diesel on July 27. Multiple search warrants were executed and some stolen property from the burglary was recovered. He was charged with Burglary and Theft by Unauthorized Taking (x2). The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

Arrest on Warrant: August 12, 2021 With the assistance of the Hillsborough County Sheriff's Office, an adult male was arrested on a warrant at a residence in Manchester in connection to the burglary at TMS Diesel on July 27. He was charged with Burglary, Theft by Unauthorized Taking, and Criminal Liability for Conduct of Another (x2). The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

Arrest on Warrant: August 12, 2021 With the assistance of the Hillsborough County Sheriff's Office, an adult female was arrested on warrants at a residence in Manchester. She was transported to the Weare Police Department to complete the brooking process. Her involvement in the TMS Diesel Burglary which occurred on July 27 is still being investigated and criminal charges are anticipated.

Domestic Violence: August 12, 2021 An adult female was arrested at her residence after Weare Police Officers were dispatched to the residence for a reported domestic dispute. After a brief investigation she was charged with Simple Assault.

Arrest on Warrant: August 13, 2021 An adult male turned himself into the Weare Police Department on an active arrest warrant from an incident which occurred on July 9, 2021. He was charged with one count of Criminal Mischief.

Driving While Intoxicated: August 14, 2021 An adult male was arrested after Weare Police attempted to conduct a motor vehicle stop for an observed violation. The operator refused to stop and a low speed pursuit occurred. The Hillsboro Police Department joined the pursuit at which time the Weare Police terminated their involvement. The operator was ultimately stopped utilizing "stop sticks" which resulted in all four tires deflating and no injuries to any parties involved. The operator was ultimately arrested for Disobeying an Officer, Driving While Intoxicated, Open Container, and multiple motor vehicle infractions.

Reckless Conduct; Deadly Weapon: August 17, 2021 An adult male was arrested after Weare Police were dispatched to a residence regarding a rock being thrown through the windshield of a vehicle in motion. Based on the investigation, it was determined the calling party was the primary aggressor. He was arrested for Domestic Violence, Criminal Threatening Against Person with a Deadly Weapon, Reckless Conduct with a Deadly Weapon, 2nd Degree Assault and Driving While Intoxicated. The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

Simple Assault: August 22, 2021 An adult male turned himself into the Weare Police Department on an active arrest warrant. The warrant stems from a physical altercation which occurred at Country Three Corners on July 5, 2021. He was charged with Simple Assault and Criminal Mischief.

Disorderly Conduct: August 23, 2021 An adult male was arrested after Weare Police received an E911 call from a citizen reporting an unknown male who was kicking on their front door attempting to gain entry. Officers arrived and placed the male into custody without incident. Through further investigation it was learned the male was on parole. He was initially charged with Disorderly Conduct and Criminal Mischief. Once at the Weare Police Department, Officers located a bag of suspected heroin. He was additionally charged with Possession

of a Controlled Drug and Falsifying Physical Evidence. The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

Driving While Impaired: August 23, 2021 An adult male was arrested after Weare Police Officers conducted a motor vehicle stop for observed violations. After officers made contact, the driver displayed signs of impairment and was placed under arrest for Driving While Impaired and Open Container. New Hampshire State Police assisted at the Weare Police Department in conducting a Drug Recognition Evaluation.

Domestic Violence; Criminal Threatening: August 24, 2021 An adult male was arrested after Weare Police responded to a reported domestic violence incident. Based on statements provided on scene, the male was charged with Domestic Violence-Criminal Threatening. The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

Protective Custody: August 25, 2021 An adult male was taken into protective custody after Weare Police Officers received an E911 call concerning a domestic dispute. Officers met with both parties and ultimately placed the adult male in custody. No criminal charges were filed.

Electronic Bench Warrant: August 25, 2021 An adult male was arrested in the parking lot of the Weare Police Department after it was discovered he had an electronic bench warrant out of Hampton District Court.

Arrest on Warrant: August 25, 2021 An adult male was arrested at the Weare Police Department after it was discovered he had outstanding warrants issued by New Hampshire Liquor Commission.

Driving While Intoxicated: August 30, 2021 An adult male was arrested after Weare Police Officers investigated an accident where a motor vehicle struck a dog and nearly hit the dog's owner. Officers contacted the vehicle operator, who displayed signs

of impairment. He was arrested and charged with Driving While Intoxicated and Driving While Intoxicated (2nd Offense).

Domestic Violence; Criminal Threatening: August 31, 2021 An adult male was arrested after Weare Police responded to a reported domestic violence incident. Based on statements provided on scene, the male was charged with Domestic Violence-Criminal Threatening. The case has been sent to the Hillsborough County (North) Attorney's Office for prosecution.

Bullying

Bullying is most commonly known to happen amongst children throughout a school day; however, bullying can be experienced by both children and adults. There are various types of bullying that occur and though some acts of bullying are obvious to spot, some may be more subtle. Types of bullying you should be on the lookout for are Physical Bullying, Verbal Bullying, Social Bullying, and Cyber Bullying.

The Definition of Bullying: an unwanted, aggressive behavior that involves a real or perceived power imbalance

Physical Bullying

The act of hurting a person's body or destroying their possessions. Physical bullying includes: hitting, kicking, pinching, spitting, tripping/pushing, taking or breaking someone's belongings.

If your child comes home with unexplained scrapes and bruises or has damaged belongings or clothes, ask them if they are being bullied. It may be an uncomfortable conversation for your child to admit they are being bullied, but their well-being takes precedence!

Verbal Bullying

The act of saying or writing hurtful things. Verbal bullying includes: teasing, name-calling, taunting, and threatening to cause harm.

Verbal bullying can cause the target to feel fearful in an environment they should ordinarily feel safe in. Verbal bullying may seem harmless, but it can

cause an individual to live in a constant fear from the continued threats they receive from their bully.



Social Bullying

The act designed to harm someone's social reputation or cause humiliation. It is often difficult to spot because it can be carried out behind the person's back. Social bullying can include leaving someone out on purpose, telling other children not to be friends with someone, spreading rumors about someone, and embarrassing someone in public.

Cyber Bullying

The use of technology which is used to harass, threaten, embarrass, or target another person. Online threats and mean, aggressive, or rude texts, tweets, posts, or messages all count as Cyber Bullying!

Social Media has transformed where, when, and how bullying is taking place. Bullies tend to feel safe behind the screens of their cell-phones and computers, this helps contribute to cyber bullying.



What you can do to prevent cyber bullying:

- Don't contribute to online bullying, even if your friends encourage you to do it. You know what's right and wrong; aim to be a role model in your friend group.
- Don't encourage bullies by "liking" or sharing their comments or posts. "Liking" content reinforces a person's behaviors.
- Block and report harassers. Many Social Media sites like Instagram, TikTok, and Facebook have safety centers where you can report harassment.
