## ARRESTS

### **April 7<sup>th</sup>: Domestic Violence (DV); Simple Assault**

We responded to Bogue Road for a report of a domestic assault. Christopher Evans, 41, of Weare, NH, was arrested for DV Simple Assault. Evans was transported to the Weare Police Department for booking and released on personal recognizance bail with an arraignment set for Goffstown District Court.

### **April 13<sup>th</sup>: Driving Under the Influence (DUI) & Open Container**

– We responded to a report of a vehicle off the side of Clough Park Road. Upon arrival, we spoke with the operator and suspected he was under the influence of alcohol. Christian Tefft, 64, of Dunbarton, NH, was subsequently arrested for

DUI. Tefft was also cited for having an open container. Tefft was transported to the Weare Police Department for booking and released on personal recognizance bail with an arraignment date for Goffstown District Court. Tefft was released to the custody of a sober adult and the vehicle was towed from the scene.

**April 14<sup>th</sup>: Driving Under the Influence (DUI) & Open Container** – While patrolling South Stark Highway, an officer stopped a vehicle after observing it having lane control issues. While speaking with the operator, Sean Liles, 27, of Hillsboro, NH, it was suspected Liles was driving under the influence. Liles was arrested and transported to the Weare Police Department for booking. Liles was released on personal recognizance bail and given an arraignment date for Goffstown District Court. Liles was released to the custody of a sober adult and the vehicle was towed from the scene.

**April 17<sup>th</sup>: Driving Under the Influence 2<sup>nd</sup> (DUI), Speed 25+ Over Limit & Open Container** – While patrolling South Stark Highway, an officer observed a motor vehicle traveling 75MPH in a 50MPH zone. A motor vehicle stop was conducted. While speaking with the operator, Mark Bilodeau Jr, 41, of Weare, NH, it was suspected Bilodeau was driving under the influence. Bilodeau was subsequently arrested and transported to the Weare Police Department for booking. Bilodeau was released on personal recognizance bail, given an arraignment date for Goffstown District Court and released to the custody of a sober adult. The vehicle was towed from the scene.

**April 20<sup>th</sup>: Driving Under the Influence (DUI) & Yellow/Solid Line Violation** – While patrolling South Stark Highway, an officer observed a motor vehicle having lane control issues. A motor vehicle stop was conducted and while speaking with the operator, Nathan Dempsey, 41, of Weare, NH, it was suspected Dempsey was driving under the influence. Dempsey was arrested, transported to the Weare Police Department for booking and released on personal recognizance bail with an arraignment date

at Goffstown District Court. A sober adult picked Dempsey up and the vehicle was towed from the scene.

**April 21<sup>st</sup>: Driving after Revocation/Suspension & Stop Sign** – While patrolling Perkins Pond Road, an officer observed a vehicle continue straight from Mountain Road to Peacock Hill without stopping at the posted stop sign. A stop was conducted and Hannah Edwards, 19, of Weare, NH, was found to be driving with a suspended driver license. Edwards was issued a hand summons in lieu of physical arrest with an arraignment date for Goffstown District Court. The vehicle was removed from the scene by a licensed driver.

**April 22<sup>nd</sup>: Driving after Revocation/Suspension & Suspension of Vehicle Registration** – While patrolling Deering Center Road, an officer observed a motor vehicle affixed with an expired inspection sticker. The vehicle was stopped and we discovered the operator, Bridgitte Ferris, 34, of Stoddard, NH, had a suspended driver license and vehicle registration. Ferris was issued a hand summons in lieu of physical arrest with an arraignment date for Goffstown District Court. The vehicle was towed from the scene.

**April 21<sup>st</sup>: Reckless Operation** – While patrolling Dustin Tavern Road, an officer observed a motor vehicle driving 75MPH in a 35MPH zone. The juvenile operator was issued a hand summons in lieu of physical arrest and an arraignment date for Goffstown District Court.

**April 25<sup>th</sup>: Arrest on Warrant** – Weare Police responded to Etta Lane for a report of a domestic dispute. Officers arrived, investigated, and found no crime had occurred. During the investigation, we learned a person on scene had an active arrest warrant out of Hampstead, NH. Amanda Wells, 24, of Weare, NH, was arrested, booked and transported to the Rockingham County Department of Corrections.

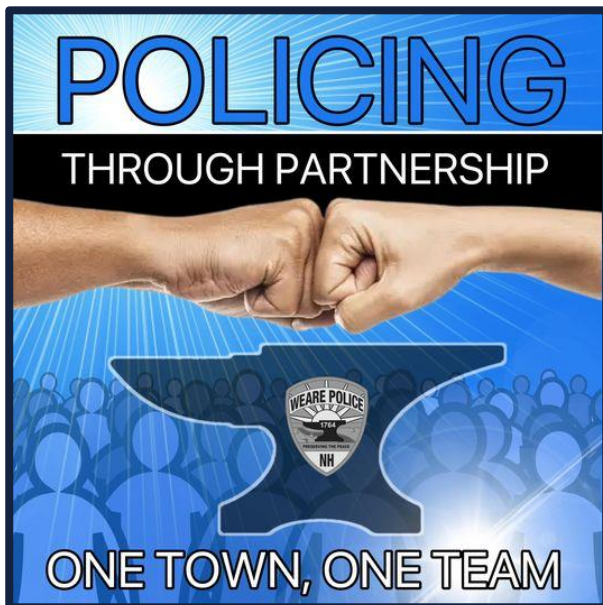
