

ARRESTS

Feb. 1st: **Drive After Revocation/Suspension (DUI)** & Interlock Device Not Equipped – While patrolling South Stark Highway an officer observed a person driving who was known to have a suspended license. A stop was conducted and the operator, Eric Myers, 53, of Weare, NH, was confirmed to be actively suspended. Myers was arrested and transported to the Weare Police Department for booking. Myers was released on personal recognizance bail with an arraignment date at Goffstown District Court.

Feb. 3rd: Incest (x3), Aggravated Felonious Sexual Assault (x3) & Endangering the Welfare of a Minor (x3) – Weare Police received a report of a

sexual assault. An investigation was immediately conducted followed by application for an arrest warrant. With the assistance of Bow PD, the suspect was arrested in Bow. As this case remains open and given that juveniles are involved, no additional information will be released at this time.

Feb. 4th: Driving Under the Influence, DUI 2nd, Controlled Drug – Acts Prohibited (x2), Unlawful Possession 3/4oz or Less of Marijuana & Speeding 21-25 MPH Over Limit – While patrolling South Stark Highway, an officer observed a motor vehicle traveling above the posted speed limit. A motor vehicle stop was subsequently conducted. While speaking with the operator, Justin Janvrin, 41, of Weare, NH, it was suspected Janvrin was driving under the influence. Janvrin was arrested and transported to our Police Department for booking. Janvrin was released on personal recognizance bail, handed an arraignment date for Goffstown District Court and released to the custody of a sober adult. The vehicle was towed from the scene.

Feb. 5th: Simple Assault (x2), Criminal Mischief & Disorderly Conduct – In January 2023, we responded to an assault at the South Weare Mobile Home Park. An investigation was launched and arrest warrants were ultimately granted. Jeffrey Gibbons, 58, of Weare, NH, turned himself in at our Police Department to answer for the charges. Gibbons was booked and released on personal recognizance bail with an arraignment date at Goffstown District Court.

Feb. 5th: Simple Assault, 2nd Degree Assault & Disorderly Conduct – In connection with the above stated Adam Pratte, 52, of Weare, NH, also reported to our Police Department to answer an arrest warrant. Pratte was booked, released on personal recognizance bail and handed an arraignment date for Goffstown District Court.

Feb. 6th: Driving Under the Influence Aggravated, DUI 2nd, Disobeying an Officer, Open Container, Operate after Certification as Habitual Offender, Interlock Device Not Equipped & Drive After Revocation/Suspension (DUI) – While patrolling Reservoir Drive an officer observed a suspicious motor vehicle and therefore ran the plate. The officer

found that the registered owner of the vehicle had a suspended driver license and was certified as a habitual offender. Jon Walker, 60, of Weare, was arrested. During the arrest an open container of alcohol was located in the vehicle. Walker was transported to our Police Department for booking and was held without bail by the bail commissioner. Walker was transported to the Hillsborough County Department of Corrections to await an arraignment the following day.

Feb. 7th: Driving Under the Influence – While patrolling South Stark Highway, an officer stopped a motor vehicle for traveling above the posted speed limit. While speaking with the operator, Michael Doyle, 47, of Deering, NH, it was suspected Doyle was driving under the influence. Doyle was arrested and transported to our Police Department for booking. Doyle was released on personal recognizance bail, handed an arraignment date for Goffstown District Court and released to the custody of a sober adult. The vehicle was towed from the scene.

Feb. 11th: Drive After Revocation/Suspension – While patrolling Concord Stage Road, an officer stopped a vehicle found to be traveling above the posted speed limit. During the interaction, it was discovered the operator, Joan Lavalley, 65, Weare, NH, had a suspended driver license. Lavalley was issued a hand summons in lieu of physical arrest with an arraignment date at Goffstown District Court. A licensed driver arrived on scene to remove the vehicle.

Feb. 12th: Driving Under the Influence (DUI) – We responded to a *Be on the Lookout* (BOLO) for a motor vehicle complaint out of Goffstown that included a hit and run crash. Weare Police located the vehicle and conducted a stop. While speaking with the operator, David Trimbur, 69, of New Boston, NH, it was suspected Trimbur was driving under the influence. Trimbur was arrested and transported to the Weare Police Department for booking. Trimbur refused bail and was transported to the Hillsborough County Department of Corrections to await an arraignment set for the next court day. The vehicle was driven from the scene by a sober driver.

Feb. 12th: Reckless Operation, Unlawful Passing on Left, License Required, Criminal Mischief & Conduct After an Accident – In January 2023, we responded to a hit and run crash at the intersection of South Stark Highway and Dustin Tavern Road. An investigation was conducted and the operator who was suspected of fleeing the scene of the crash was identified as Aaron Beattie, 44, of Henniker, NH. Beattie responded to our Police Department and was issued a hand summons in lieu of physical arrest with an arraignment at Goffstown District Court.

Feb. 13th: Bench Warrants – While patrolling Concord Stage Road, an officer stopped a vehicle for speed. The officer found that the registered owner of the vehicle had an active civil arrest warrant. The officer learned that the owner (Anthony Oglesby, 44, Penacook, NH) was the passenger. Oglesby was arrested and transported to the Weare Police Department for booking. Oglesby was released after paying court determined monies owed to the bail commissioner. An arraignment date for Merrimack County Superior Court was set.

Feb. 15th: Criminal Trespass, Simple Assault (x4) & Domestic Violence (DV); Obstructing Report of Crime – We responded to a reported domestic assault on Rolling Hill Drive. An investigation was conducted and Megan Morin, 40, of Merrimack, NH was arrested. Morin was transported to our Police Department for booking, released on personal recognizance bail and handed an arraignment date for Goffstown District Court.

Feb. 16th: Suspension of Vehicle Registration,
Unregistered Vehicle, Stop/Stand/Park Prohibited,
License Required; Operating with an Expired
License – Subsequent & Drive After
Revocation/Suspension – In January 2023, we
responded to a report of an abandoned motor vehicle
on Deering Center Road that was impeding traffic.
We found the vehicle but were unable to locate an
operator. An investigation was conducted and the
operator identified. An arrest warrant was requested
and granted for Kayla Stone, 26, of Weare, NH. Stone
later responded to the Police Department to answer for
the charges. Stone was booked and released on

personal recognizance bail with an arraignment for Goffstown District Court.

Feb. 16th: Electronic Bench Warrant – Kimberly Stone, 22, of Hillsboro, NH, was arrested at the Weare Police Department. Stone was booked and released on personal recognizance bail with an arraignment for Merrimack District Court.

Feb. 19th: Disorderly Conduct, Resist Arrest/Detention, Controlled Drug: Schedule 1-4; Possession (x2), Falsifying Physical Evidence, Controlled Drug: Sale – Methamphetamine & Controlled Drug: Sale – Fentanyl – We responded to a report of a suspicious motor vehicle at Lanctot's Plaza. When we arrived and met with the two occupants a controlled drug was observed in plain view.

Melissa Eaton, 32, of New Boston, NH then became disorderly and resisted detention. Eaton was arrested and transported to our Police Department for booking. A search warrant was granted for the vehicle, and we subsequently seized controlled drugs, drug paraphilia and other drug related equipment. Eaton was released on personal recognizance bail with an arraignment for Goffstown District Court.

Feb. 19th: Disorderly Conduct, Controlled Drug: Schedule 1-4; Possession (x2), Controlled Drug: Sale – Methamphetamine, Controlled Drug: Sale – Fentanyl & Electronic Bench Warrant (EBW) – In connection with the above stated arrest and during the officer's inquiries, we found that Matthew Mellow, 38, of Manchester, NH had an active EBW. Mello became disorderly, was arrested and transported to the Police Department for booking. Mellow was released on personal recognizance bail with an arraignment for Goffstown District Court.

Feb. 20th: Driving Under the Influence, DUI Aggravated; 30+MPH, Open Container, Speeding 26+MPH Over Limit – While patrolling Dustin Tavern Road, an officer stopped a vehicle for traveling 65MPH in a 35MPH zone. While speaking with the operator, Joshua Kiskinis, 23, of Auburn, NH, it was suspected Kiskinis was under the influence. An open container of alcohol was also

located in the vehicle. Kiskinis was arrested, transported to the Police Department for booking and released on personal recognizance bail with an arraignment date for Goffstown District Court. Kiskinis was released to the custody of a sober adult.

Feb. 21st: Driving Under the Influence – While patrolling Deering Center Road, officers observed a vehicle parked in front of a *No Parking Zone* in a dirt parking lot. The vehicle was running and a person was standing outside the vehicle looking for something in the front drivers area. While speaking with the operator, Deric Farris, 26, of Weare, NH it was suspected he Farris was under the influence of alcohol. Farris was subsequently arrested, transported to our Police Department for booking and released on personal recognizance bail with an arraignment for Goffstown District Court. Farris was released to the custody of a sober adult.

Feb. 24th: Driving Under the Influence, Unlawful Possession/Intoxication (x3), Transportation of Alcoholic Beverages by a Minor, Open Container & Possession/Use Tobacco Products by a Minor -While patrolling South Stark Highway, and after observing a vehicle make evasive maneuvers in what appeared to be an attempt to distance from the police, we conducted a motor vehicle stop. Officers met with the operator, Wyatt Plamondon, 18, of Weare. At this time, it was suspected that Plamondon was driving under the influence. Plamondon was arrested and transported to our Police Department for booking. Alcohol was observed in plain view inside of the vehicle. Plamondon was released on personal recognizance bail, handed an arraignment date for Goffstown District Court and released to the custody of a sober adult. The vehicle was towed.

Feb. 25th: Electronic Bench Warrant (EBW) (x4) – While assisting Weare Fire & Rescue at a residence on South Stark Highway, it was discovered a female on scene had active EBW's. Veronica Paris, 39, of Goffstown, NH, was arrested and transported to our Police Department for booking. As Paris was unable to pay the predetermined cash bail set by the court, she was transported to the Hillsborough County

Department of Corrections where she was arraigned the following court day.

Feb. 25th: Electronic Bench Warrant (EBW) (x2) – In connection with the above stated arrest, it was discovered another person on scene had active EBW's. Michael Leroux, 43, of Weare, was arrested and transported to our Police Department for booking. Leroux was also unable to pay the predetermined cash bail set by the court and therefore transported to the Hillsborough County Department of Corrections to await arraignment set for the following court day.

Feb. 27th: Domestic Violence (DV); Simple Assault – We responded to a reported domestic assault on River Road. An investigation was conducted and Justin Coombes, 31, of Weare was arrested. Coombes was transported to our Police Department for booking, released on personal recognizance bail and handed an arraignment date for Goffstown District Court.
