



It may be at work, the gym, the grocery store, the mall, or the movie theater!

There are countless locations where we may find ourselves in a parking lot where criminals can easily approach us! Being aware of your surroundings decreases your chances of becoming a victim!

- -Prior leaving the store or building, make sure you visibly scan the parking lot and other outside areas for anyone loitering or appearing suspicious.
- -We also encourage you to approach your vehicle with your keys already in hand and to look <u>all the</u> <u>way around</u> your vehicle for any suspicious activity before getting behind the wheel.
- -If you believe someone is stalking or following you, immediately go back in the store or building!
- -Always have your cell phone close by in the event you need to dial **911**.
- -Purposely set off your car's alarm to alert others, draw attention to yourself.
- -Once you do get inside of your vehicle, LOCK THE DOORS...then buckle up and exit the parking lot.

-Use **extra caution** when you leave a bank or ATM location. Even after driving away make sure you are not being followed.

Arrests

Unlawful Possession/Intoxication (x2): July 1–During a medical call on Daniel's Road two males were issued hand summons for being intoxicated and under the age of 21. They were in the care of a sober adult and were issued a Goffstown District Court date to appear.

Driving after Revocation/Suspension – Subsequent, Operating without a Valid License, Misuse of Plates, Uninspected Vehicle, Unregistered Vehicle: July 3 – While on patrol on Deering Center Road, a motor vehicle stop was conducted for a vehicle without an inspection sticker and failing to display a front license plate. During the roadside investigation it was determined the operator's driver's license was currently suspended. Other infractions were also discovered. The operator was issued a hand summons with a date to appear before the Goffstown District Court.

Operating after Certification as Habitual Offender, Operating without a Valid License, Driving after Revocation/Suspension, Possession of a Schedule 1-4 Controlled Drug. Unregistered Vehicle, Speeding 11-15 over posted limit. : July 4 - While patrolling River Road, a motor vehicle stop was conducted for a vehicle traveling 45 MPH in a posted 30 MPH zone. During the roadside investigation it was determined the operator's driver's license was currently suspended/canceled due to certification as a Habitual Offender. The operator was transported to the Weare Police Department for booking.

A tow inventory was conducted prior to the vehicle's removal and Suboxone was discovered inside. The operator did not have a prescription for the narcotic. The arrested party was released on personal

recognizance bail and a court date was scheduled for the Hillsborough County (North) Superior Court.

Reckless Conduct – Deadly Weapon,
Unauthorized Use of a Motor Vehicle, Operation
without a valid License, Criminal mischief
(JUVENILE): July 6 – A juvenile was taken into
custody for operating a vehicle recklessly without a
driver's license and without permission to be
operating the vehicle. No further information is
available due to age and protections afforded to the
minor.

Simple Assault, Unlawful Possession ¾ oz or less of Marijuana (JUVENILE): July 7- We were at a residence assisting Juvenile Probation/Parole when an assault occurred. No further information is available due to age and protections afforded to the minor

Subsequent Possession of a Controlled Drug, Schedule 1-4 (x2) July 13– We were dispatched to suspicious activity on River Road regarding a female and male acting odd. The reporting party was concerned as these people were pointing towards private property and had numerous bags with them. The calling party was unsure if they were planning to camp on the private property. Upon arrival, we located a man and woman in the woods.

During a consent search suspected methamphetamine was discovered. Drug paraphernalia was also located. The female was arrested and released on personal recognizance bail with a court date for the Hillsborough County (North) Superior Court. The male was not charged.

Endangering the Welfare of a Child: July 16– Weare Police responded to Autumn Hills Campground for a report of child abuse. When police arrived they spoke with all parties and arrested the adult male who was left in charge of the young child while the parents were away. He was booked and released on personal recognizance bail with a date to appear before the Goffstown District Court. The child was unharmed. DCYF was involved in this investigation.

Arrest on Warrant: July 20– We executed a Bedford Police Department (BPD) arrest warrant on Twin Bridge Road. A male was taken into custody without incident and transported to the BPD.

Domestic Violence (DV), Simple Assault/Criminal Threatening with a Deadly Weapon, Endangering the Welfare of a Child, Resisting Arrest: July 24-

We responded to Etta Lane for a 911 call regarding a DV assault. Officers asked the reporting party to meet them away from the home and she did. The woman explained what had occurred. The allegations included physical assault, criminal threatening with a deadly weapon, hindering the report of the crime. When officers attempted contact with the suspect he physically resisted detention/arrest. After a brief struggle officers took him into custody without injuries. He was booked and released on personal recognizance bail with a court date for the Hillsborough County (North) Superior Court.

Domestic Violence (DV) Simple Assault: July 26-

We responded to River Road for a reported verbal DV dispute between brothers. Officers spoke with both men and determined one had assault the other. The suspect was arrested, booked and released on personal recognizance bail with a court date to appear before the Goffstown District Court.



Interacting with Police

School Bus and School Zone Safety

The Weare Police Department wants to ensure the safety of your children by reminding you how to safely operate your motor vehicle when approaching a school bus or when driving within a school zone.



When entering a School Zone

SLOW DOWN!!! It is that simple; unfortunately, people do not follow speed limits within school zones. Drive as if there are always children present during school hours.

Please remember to always slow down, look for traffic signals/signs, reduce your speed, avoid passing other vehicles, and lastly never drop your kids off in the street

Dropping off in a School Zone

Do not- double park, it blocks visibility for children and vehicles.

Do not- load or unload children across the street from the school.

Do- Ensure your kids make it safely onto the sidewalk and are supervised.



Sharing the Road with School Buses

When you are driving behind a school bus, please leave at least 25 feet of following distance between yourself and the school bus. This allows you more time to stop once the yellow lights start flashing. The greatest danger presented while taking a school bus is when the students are approaching or leaving one.

Yellow flashing lights: indicates the bus is preparing to stop to load or unload children. Motorists should slow down and prepare to stop their vehicles.

Red flashing lights and extended stop arms: indicates the bus has stopped and children are getting on or off. Motorists must stop their cars and wait until the



red lights stop flashing, the extended stop-arm is withdrawn, and the bus begins moving before they can start driving again.

Reminder:

According to NH RSA 265:60, In a posted school zone, at a speed of 10 miles per hour below the usual posted limit from 45 minutes prior to each school opening until each school opening and from each school closing until 45 minutes after each school closing.

Be alert, children are often unpredictable and they tend to ignore hazards and take risks. Expect the unexpected around a school bus, and be on alert for children!
